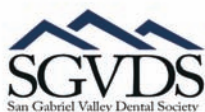

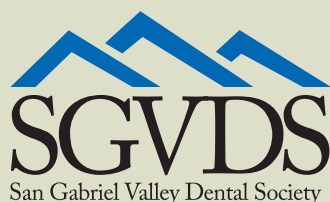

I look forward to 2015 as I begin my second tenure as the President in which I will serve the dentists of the San Gabriel Dental Society. It has been said that you have to recycle to get it right!! (Laughing) Well, due to an unexpected vacancy on our board I agreed to lead our organization once again and I plan to get it right.

We have a great team of new and returning volunteers to represent us locally and at the State and National levels. The newly updated SGVDS website (thanks to the efforts of Dr. Amy Tran's committee) is up and running and the California Employer's Association (CEA) Human Resources Hotline continues to be a great benefit for our members. We are one of only a couple of local components in the state that provides this benefit for our members. It is administered by the California Employers Association in an effort to protect our businesses from costly fines and penalties.

We will continue to support our new members with new member socials, provide dental examinations for local children, and provide continuing education opportunities for our members in a manner that is, in my opinion unmatched.

In addition, with the help of the ADA and CDA, we will continue to be a strong voice to our legislators in health care matters that come before them. 2014 was a successful year in the legislature for the dental profession in California. The accomplishments include:

- Working with over 600 coalition partners to earn a landslide defeat of Proposition 46.
- Legislation that will bring greater transparency to dental plans in California and make them accountable for how they spend patient premium revenue.
- Securing ongoing funding in the state budget for a state dental director, a position the state has not funded in decades, who will oversee a comprehensive state oral health program.



- Preventing the "claw back" of the Denti-Cal reimbursement rate cut that would have been retroactive to June 2011 and successfully advocated for budget language establishing Denti-Cal performance measures to evaluate utilization, access and availability of dental providers.
- Ensuring that dental coverage "embedded" in medical plans sold through Covered California must be separately monitored by state regulators to ensure the dental component of these plans maintains an adequate network of dental providers able to provide timely access to care.

One of the highlights of 2014 for me was the opportunity to act as the local chair for the CDA Cares Free Clinic at the Pomona Fairplex which occurred last November. I knew there would be a lot of work involved in finding financial support, engaging and organizing dental professionals and community volunteers and raising support from local restaurants to provide for the volunteers and patients. I also knew that there would be a lot of gratitude from the people we helped and the great feeling of accomplishment knowing that nearly 2000 patients were treated and \$1.66 million in services were provided. What I didn't realize is the magnitude of the response that we would receive from the members of our profession, including the members of the San Gabriel Valley Dental Society. Lives were changed in positive ways and many of us will have lasting memories of the event. Thank you to those of you that participated for your efforts on behalf of our less privileged. You have been an inspiration to me, the patients and even to the media and politicians who visited the event. I know we all received more than we gave.

In conclusion, I would like to personally thank Dr. Donna Klausner as our outgoing president for her excellent work in 2014 as well as that of our Board of Directors, Committee Chairpersons and their members for their hundreds of hours of volunteer work. I would also like to thank Lee Adishian, our executive director, and her staff for their help.

TAX CORNER

Claiming the Small Business Health Care Tax Credit

Under Sec. 45R, the Small Business Health Care Tax Credit was targeted to small businesses and small tax-exempt organizations to provide health insurance coverage for their employees.

For tax years beginning in 2014 or later

- The maximum credit is 50% of the small business employer's contribution toward the employees' health insurance premiums and 35% of premiums paid for small tax-exempt employees.
- To be eligible for the credit, a small employer must pay premiums on behalf of employees enrolled in a qualified health plan offered through a Small Business Health Options Program (SHOP) Marketplace or qualify for an exception to this requirement.
- The credit is available to eligible employers for two consecutive taxable years.

To be eligible, a small employer must:

- Cover at least 50 percent of the cost of employee-only (not family or dependent) health coverage.
- Have no more than 25 full-time equivalent employees (FTE) for the taxable year,
- Have average annual wages of less than \$50,800 per FTE (as adjusted for inflation beginning in 2014) per year.

The credit amount is based on a sliding scale. The smaller the business or charity, the bigger the credit. Should the average annual wages increase between \$25,400 and \$50,800 for 2014 and/or the average FTE increases between 10 and 25, then the credit will be less.

IRS Form 8941, Credit for Small Employer Health Insurance Premium will be used to claim the credit. For a small business, the credit may be able to carry back one year and forward 20 years. The credit can be applied to both regular taxes and the alternative minimum tax. For a tax-exempt employer, the credit can be refundable and is limited to payroll taxes for the tax year.

Mandatory Paid Sick Leave: Employers must post by January 1, 2015 a poster on the new California law that requires employers provide paid sick leave to employees as of July 1, 2015. Download and print the poster from the California Division of Labor Standards Enforcement (DLSE) web site, [http://www.dir.ca.gov/DLSE/Publications/Paid_Sick_Days_Poster_Template_\(11_2014\).pdf](http://www.dir.ca.gov/DLSE/Publications/Paid_Sick_Days_Poster_Template_(11_2014).pdf). DLSE also has on its web site responses to frequently-asked-questions, http://www.dir.ca.gov/dlse/Paid_Sick_Leave.htm. Information on the application of the new law in dental practices will be published on cda.org and in the January CDA Update.



Time Off for Emergency Duty: An employee who is a healthcare provider and takes time off to perform emergency duty as a volunteer firefighter, a reserve peace officer, or emergency rescue personnel may not be discharged or discriminated against by the employer for fulfilling emergency duty. The employee must notify his or her employer when designated as emergency personnel and when emergency duty commences.

Discrimination/Harassment: Certain protections are now extended to unpaid interns and volunteers.

Minimum Wage: The state minimum wage goes up on January 1, 2016, and the new wage is already included in the current state minimum wage poster. However, you should be aware of any local ordinance establishing a higher minimum wage. San Francisco, San Jose, and Oakland have set higher minimum wages. We are aware that other communities, such as Los Angeles, are examining minimum wage increases.

Dental Practice Act: A few changes were made to licensing and disciplinary procedures, specific to licensure fees, portfolio licensure, sexual misconduct, and substance abuse. You can review the changes on the Dental Board web site, <http://www.dbc.ca.gov/lawsregs/index.shtml>, under Approved Regulations. The scope of practice was revised for dental auxiliaries working in public health settings utilizing telehealth. A revised table of dental auxiliary duties will be available in late spring.

Prescription Drug Monitoring Program: Prescribers with DEA registration must register to access this program by January 1, 2016. No fee is required to register. Registration information is available on the Department of Justice web site, <http://oag.ca.gov/cur-es-pdmp>.

HIPAA: Covered entities must submit their log of breaches (affecting less than 500 individuals) to the Department of Health and Human Services no later than March 1 of each year.

PAID SICK LEAVE LAW IN CALIFORNIA

The Healthy Workplace, Healthy Families Act of 2014 (AB 1522) was signed into law in 2014. The basic intent of the law is to provide all employees with at least three days or 24 hours of paid sick leave each year.

What does this mean for you as an employer?

Effective January 1, 2015 ALL employers must post a Paid Sick Leave Notice in their place of business. Effective July 1, 2015, ALL employers, both public and private, will be required to provide paid sick leave to all of their employees, with a few exceptions (unionized workers, home health care providers and airline flight crews).

What does AB 1522 mean for employees?

Under AB 1522, ALL employees who work in California for 30 or more days in a calendar year, will earn paid sick leave at a rate of one hour for every 30 hours worked! This accrual method begins as of 7/1/15 and employees

must be allowed to use any accrued time after 90 days of employment. (Former employees that are re-hired within one year are entitled to have previously accrued and unused paid sick days be reinstated.)

Employers will be allowed to limit an employee's use of paid sick days to three (3) days per year and can cap accrual of paid sick leave at six days.

Another option to the accrual method described above is to give employees all of their paid sick leave up front. This has been called "front loading" "the lump sum method" or "granted leave". In each case, employers are permitted to grant three or more days of paid sick leave at the start of the year to their employees to avoid the administrative burdens of tracking accrual and carry over.

When can employees use AB 1522?

Employees can use AB 1522 to take paid leave for themselves or a family member for preventive care or care of an existing health condition or for specified purposes if they are a victim of domestic violence, sexual assault or stalking.

Family members include the employee's parent, child, spouse, registered domestic partner, grandparent, grandchild, and sibling. Preventive care would include annual physicals or flu shots. **For partial days employers can require leave be taken in two hours increments**, but otherwise the determination of how much time is needed is left to the employee.

Existing law already requires employers that provide paid sick time to allow employees to use half of their yearly allotment for "kin care" (care of their sick child, parent, spouse, registered domestic partner). The new law does not repeal "kin care" but expands it to include grandparents, grandchildren and siblings.

Employers with more generous plans will have to allow employees to use 1/2 of the annual sick leave entitlement for Kin Care.

Posting, Notice and Record Keeping Requirements

In addition to accounting for and providing the accrued leave, employers are required to:

- Display a Paid Sick Leave Poster as of 1/1/2015
- Include the amount of paid sick leave accrued on employees' itemized wage statements
- Retain all paid sick leave records for three years
- Use the revised Wage Theft Prevention Act Notice on or before 7/1/15

What if I already provide paid sick leave for my employees?

California employers who already provide at least three days of paid sick time, will now have additional administrative requirements, including:

- Recording an employee's sick leave balance on itemized wage statements, or another writing, on each pay day.
- Carryover of accrued sick leave with the cap of six days.
- Documentation showing hours worked as well as paid sick days accrued and used by an employee.

Rate of Pay

Employees should be paid their regular rate of pay for sick leave. However, if your employee is paid different hourly rates, is paid a commission, is paid by piece rate or flag rate, etc. then you must "Divide employee's total wages, not including overtime premium pay, by the employee's total hours worked in the full pay period of the prior 90 days of employment" to determine an hourly rate to be paid for sick leave.

What's the good news?

Employers are not required to pay out accrued sick time at termination.

California Employers Association is here to assist you in navigating this new law. We have webinars dedicated to this topic in December, February and again in June.

We can assist you in developing a Paid Sick Leave Policy that fits your company's needs. By July 1, 2015 you will be informed and ready to address this new law with your employees and in your employee handbook.



Recommendation and Source Information

Don't change your policy or create a new one just yet! This bill was just passed and there are still many unanswered questions. *For now, get informed, ask questions and watch for our updates.*
